## **Suggested Guidelines: Of The Coalition Of Surf Clubs: Contest Use**

date 1999-2002

1. Heats will be 15 minutes , Final heats will be 20 minutes
  2. Each heat will begin and end with one horn blast and display of green flag. A five minute warning will be given with two horn blasts and the display of yellow or green flag. At the conclusion of the heat competitors will immediately return to the beach as the next heat begins. If a competitor stands up before the beginning of the heat it will result in the loss of the points scored for the highest scoring wave for the competitor earned in that heat. Exiting competitors must not stand up after the conclusion of their heat. Violation of this will result in a deduction of the lowest scoring wave of the competitors heat total.
  3. In all water starts, competitors may enter the water at the five minute warning(two horn blasts) Competitors waiting for their heat to start must stay clear of heat in progress. Failure to do so, will result in paddling interference, loss of lowest scoring wave in scoring wave of competitors wave total.
  4. Surfboards must be a min. of 9 feet in length. Women and juniors may use boards which are 3 feet longer than the height of the contestant. No paddling gloves . Cords are optional. Contestants assumes responsibility for no cord use. A .5 will be added to the final score of those competitors who choose not to use cords.
  5. Maximum wave count and number of scoring waves will be set depending on surf conditions of contest. Competitors will be advised of the maximum waves they may catch prior to commencement of the heat. Upon reaching the maximum wave total competitors will immediately exit the water.
  6. Interference: A. The first rider up, closest to the curl has wave possession. In the event two riders stand up at the same time rider closest to the curl has possession. (standard point break rule) B. In the event two riders take off on an unbroken wave first up will have right of way. ( standard Reef or Beach Break Rule) the other rider may take off in other opposite direction. To have Possession of a wave the rider must be on his feet in front of or in the curl after the 1st turn. Any action which impedes a contestant riding or taking off on a wave by Dropping in, Taking off or Paddling in front of rider in possession will result in an Interference called ( Loss of highest scoring wave in that heat) In cases where a rider is in front of another unknowingly or so appears to judges If rider exits promptly with no impedance, no interference shall be called(No Harm No Foul) Reef and Beach Break first man up. Point break closest to the curl, has possession of make able wave, unless closed out. Type of break to be determined at the beach.
  7. Snake rule: Paddling front of or around behind a competitor to impede then as to take advantage of having position for wave possession. Known as( Snaking). an interference (Loss of highest scoring wave)
  8. Judging will be on a 10 or 20 point system with half points used when using 10 point system only. Five judges on the stand ,drop high and low scores, use the rest. Competitors will be judged on style, wave selection, Length of ride and Controlled Functional maneuvers. Shuffling or hopping back and forth on the surfboard will be considered poor style and will not be scored as high as walking.
  9. Protests must be filed in writing within 30 minutes of conclusion of heat in question, Filed in protest box or tin. Only the team captain will be allowed to speak with Contest Director or Head Judge. Failure to comply may result disqualification.
  10. All competitors must check in half hour before heat to sign waiver. Judges must check in 30 minutes before commencement of contest. Judges may surf in contest as long as they do not judge their division R.Q.R.(Ride Quality Recorder)'s decisions carry twice that of regular judge.s in all disputes.
  11. Contestants surfing in contest area will be grounds for disqualification of surfer or their club.
- Guidelines may be adjusted based upon local conditions and locations: New ones added but not taken away.
